

# KID'S KLOSET CONSIGNMENT AGREEMENT

PLEASE PRINT THIS FORM, READ/SIGN AND BRING WITH YOU TO YOUR DROP-OFF APPOINTMENT.

1. Kid's Kloset is sponsored by St. John United Methodist Church and is a consignment sale where the seller receives 60% of the proceeds and the remaining 40% are donated to designated St. John ministries or charities. 100% donations are always welcome!! Designation of proceeds for this sale will be posted as soon as approved.
2. This sale features *children's items only*, including clothing, accessories, shoes, toys, nursery items (large and small), books, videos, electronic games, puzzles, baby toys, computer games, etc. We will also sell children's furniture, such as cribs and toddler beds, changing tables, desks, etc., along with junior, young men and maternity clothes.
3. **Spring/Summer** clothing/items ONLY will be accepted for this sale.
4. Sellers pay a \$7.00 registration fee to help offset expenses. This fee will be *deducted from each seller's proceeds check* after the sale. If you are donating 100% of your proceeds to St. John's designated charities, the fee *will not* be charged.
5. **All merchandise must be clean and in good condition.** Clothing will not be accepted or placed on the floor if dirty, stained, badly worn, patched, has holes, missing buttons, tears, broken zipper, etc. Toys should have all the pieces and be in good working condition. Non-clothing items will be held to same standards.
6. All battery-operated items must be equipped with working batteries.
7. St. John reserves the right to refuse any items deemed unacceptable or inappropriate for our sale. This includes movies rated "R" or above, and video/PC games rated "M".
8. St. John will not accept responsibility for losses of, and/or damage to, any items consigned. Seller agrees to hold harmless and make no claim against St. John for any damage, theft or loss of any items consigned in sale.
9. Use only the online system for our sale. If you do not have access to a computer, or absolutely cannot use a computer, please contact us. No hand written inventory sheets or tags other than from our system will be accepted.
10. Any changes on the tags must be made on your inventory sheets in the computer and tags reprinted so the codes scan correctly. Do not make hand written changes on the tags.
11. **PLEASE NOTE:** Sellers who are not donating unsold merchandise to charity must come to St. John's gym at **2pm (on Sat. 3/24) and will have until 3pm to pull their unsold items and remove them from the gym.** All sellers must leave at 3pm, doors will be locked and any items not picked up will be donated to our designated charities. **Due to the sheer scope of this sale, WE CANNOT and WILL NOT MAKE EXCEPTIONS.** If you cannot come during this time, please make arrangements for someone else to pull your items for you. Remember you can view your account online and see what has sold and not sold. We do our best to upload this information at the end of each sale day, provided we don't run into any unforeseen system problems.

Checks will be distributed or mailed to sellers within 14 business days of the close of the sale. Dates for distribution will be given at drop-off (check-in) along with ticket for early shopping. Dates will also be sent via email to sellers, posted on our website ([www.saintjohnkidskloset.com](http://www.saintjohnkidskloset.com)), and be put on our phone message system (228-2897, ext. 170) for easy access.
